# 2ND NATIONAL MEDIATION COMPETITION, 2022

## ABOUT THE COMPETITION

Second National Mediation Competition is the second edition of the flagship event. After witnessing a great response and appreciation from the participants across 32 premier law colleges and assessors across the globe, this event is yet another step taken by the Centre for ADR and Professional Skills, HPNLU, Shimla towards acting as facilitator in increasing the Mediation among aspiring students. In the milieu of the backlog of cases reaching its saturation, Alternative Dispute Resolution such as Mediation and Negotiation provide an amicable way out.

The competition seeks to provide a prodigious experience that will amplify the interests of young minds in this niche practice of law. The competition will help students brainstorm probable solutions for a near to real challenges while providing them with the comfort of choosing their roles as per their preferences. It, therefore, tries to break the monotony of theory-based learning and helps students in putting their knowledge and skills to use.

This competition will also provide an opportunity for the participants to develop the requisite lawyering and communication skills through various training sessions conducted by industry professionals. The appealing and ever-growing fields of the law will be selected for this competition to expose the participants to a situation where the interests of clients are multifold, often going beyond mere commercial interests. The participants are expected to take a multi-dimensional approach to reach a settlement, showcasing the variety of skills that can be useful in effective of mediation.

# TRAINING WORKSHOP

The Training Workshop offers the opportunity to learn what is necessary to become an effective negotiator and a skilled mediator. Experienced and highly knowledgeable trainers introduce one to the theory and concepts that form the basis of negotiation and mediation practice. The program provides participants with the opportunity to practice this structured dispute resolution process through a series of interactive presentations, role-play simulations, real-life case studies, and discussion groups.

Through this training one will also learn how to negotiate better settlements. Because negotiation is the core component of the mediation process, this program emphasizes negotiation skills, strategies, and techniques that one can use. Negotiation is a continuum from very competitive to very collaborative. To be a complete negotiator, one must become familiar with and practice all approaches to negotiation. Beyond negotiation, this course will emphasize the communication skills that are critical in mediating and settling cases.

One will also learn how to get people to the table, how to create an environment of an agreement once they get there, and how to close the deal and bring about a lasting settlement agreement. This program will be a practical training course. While covering theory to give a framework and the intellectual understanding of negotiation and mediation, this program is about learning. The main focus is on doing, practicing, and experimenting with Negotiation and Mediation. In this program, one will learn how to be a complete mediator. The training program is only for the participants of this competition.



# GENERAL INFORMATION

## A. ELIGIBILITY

- The competition is open to every student pursuing a five-year or a three-year course in law from various Schools/Colleges/Universities recognized by the Bar Council of India.
- For eligibility, it is hereby clarified that all the participants in one team shall belong to one institution only. No cross-institutional composition of teams is allowed.
- The provisional registration is to be done by the respective institutions officially. Each institution can reserve a maximum of two slots in the provisional registration.

## B. TEAM COMPOSITION

- Each team shall comprise 3 participants- one mediator, one client, and one counsel.
- The roles of the participants shall remain the same throughout the rounds.

## C. FORMAT

- The Mediation Proposition shall be released after the closing of final registration.
- There will be two preliminary rounds.
- Post preliminary rounds, ballots will be scored for each team, and the top 8 client-counsel pair and Mediators will qualify for the quarter-finals.
- Post-quarter-finals, the top 4 client-counsel pairs, and Mediators will qualify for Semi-finals.
- The top two performers from each category of roles (Client X Counsel pair and Mediator) played by the participants will qualify for the final round.

## D. REGISTRATION

- Provisional registration will be opened for all eligible institutes from which thirty-two(32) teams will be selected for the competition.
- Selection will be based on the screening process of each team individually. The institutes must complete the “Provisional Registration” only through the Google Form link annexed below, on or before 18th August 2022.

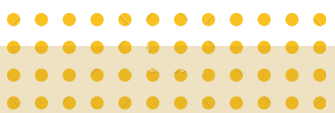
- The final list of teams (along with the waiting team list) will be released by 20th August 2022.

- Registration Amount - Rs. 3000/- per team.
