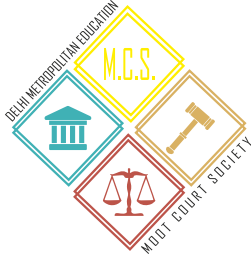

ABOUT THE EVENT

The most important aspects of being a legal professional are counselling people looking for assistance in understanding the legal consequences of their actions and to advise people seeking redressal of their grievances. It is, thus, a prerequisite for any budding lawyer to possess the fundamental skills which would help him successfully create a rapport with the client. To do this, one needs to adopt an approach that is both realistic and empathetic. DME Law School is, thus, proudly organising its 2nd National Client Counselling Competition. This competition is aimed at giving law students across the country an opportunity to not just test their legal knowledge but also to test their communication skills, convincing ability and patience. They will be judged based on:

- How well they are able to understand and handle their client's situation?
- How quickly and effectively they can respond to critical situations?
- How they approach the given legal issue?

It will help inculcate in the students the art of planning and interviewing in order to obtain all the relevant information and then analysing the information obtained. In this competition, the participants will conduct an initial interview with the client, following which there will be a post counselling session among the counsels where they will analyse the information obtained and discuss their future course of action.

All consultation problems will be related to family law. This is because Family law disputes are unique, in the sense, that they often involve complex emotional situations and require lawyers to find innovative solutions.

RULES & REGULATIONS

Rule 1. Entry into the Competition.

- (a) **Composition:** Each team shall consist of two students (only).
- (b) **Eligibility:** Law Students from any recognised University. Only one team per Institute can participate. In case more than one entries are received from the same institute, the team registering first will be allowed to participate.
- (c) **Team Codes:** After successful registration, each participating team will receive a unique team code from the organisers.
- (d) **NOC:** It is mandatory for each participant comprising a team to get the No Objection Certificate signed by the Dean/Head of the Institute. (Appendix-A) The same is to be uploaded in the Google Form. Any entry without the NOC shall be rejected immediately.

Rule 2. The Consultation Situation, Theme of the competition, Applicable laws.

- (a) **Distribution of Consultation Problem:** The participating teams will not receive the consultation problem before the competition. The problem shall be made available to the Client who shall then further present the information before the participating team in her/his own words. Based on the information so presented, the team members will decide their counseling strategy and client dealing. However, approximately 7 days before the Competition, the organizers will send to each team a brief description relating to the consultation problem. This will contain information similar to that which a law office secretary might record when informing lawyers of a forthcoming appointment.
- (b) **Theme of the Competition:** The consultation problems will be related to family law.
- (c) **Applicable Laws:** The problems shall be based on, but not limited to, on the Hindu Marriage Act, 1955, the Hindu Succession Act, 1956 and the Hindu Adoption and Maintenance Act, 1956. The participating teams are required to be familiar with the aforesaid statutes.

Rule 3. Rounds.

The competition shall consist of two rounds: Preliminary and Final. To qualify for the final round a participating team must be in the top 5 scorers in the preliminary rounds.

Rule 4. The Consultation and Post Consultation Session.

- (a) **Time limit for the Session:** Each team shall have a maximum of 25 minutes to complete the session. This includes 20 minutes for the consultation and 5 minutes for the post consultation session. Any team exceeding the prescribed time limit will be subject to negative marking.
- (b) **The Consultation Session:** Each team must conduct a consultation with the client during which the students are expected to elicit the relevant information, outline the problem, and propose options for resolving the problem. The discussion of fees is an integral part of any first consultation between a lawyer and a client. Students should be judged on how they approach this problem, but not on the monetary amount used. The participants may discuss fees at any appropriate point in the consultation. Fees may be waived or suitably reduced only in cases of financial hardship, either for persons of low income or for persons of ordinary income faced with very large fees.
- (c) **The Post-Consultation Session:** Each team must also conduct a meaningful post-consultation discussion between the attorneys after the client has left the room. In the post-consultation session the participating teams are expected to summarize the interview, indicate the next steps to be undertaken, and state the legal issues that should be researched. The teams may discuss any other relevant point as well.

Rule 5. Dress Code

The students are required to be dressed in Black and white formal attire typical of a lawyer.

Rule 6. Clients

The individuals playing clients will be selected and briefed by the organisers.

Rule 7. Panel of Judges, Judge's Critique and Marking.

- (a) **Composition of the Panel.** Each panel will consist of 2 Judges who will be invited by the organisers.

RULES & REGULATIONS (Cont.)

- (b) **Judge's Feedback:** Immediately following each team's post-consultation session, the judges shall provide the team with a feedback of the team's handling of the consultation and post consultation periods.
- (c) **Client Not to Be Present:** Clients should not be present during the post-consultation session or the critique.
- (d) **Marking Scheme:** Each team will receive a score out of 100. Each judge is required to individually mark the teams. The marking criterion is given below:
