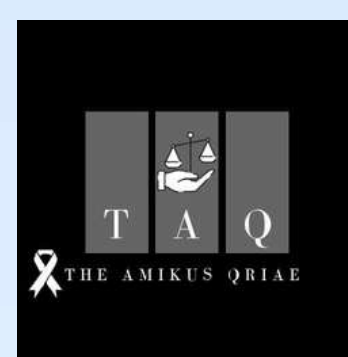


ABOUT THE LEGAL LOCK

TEAM COMPOSITION

- Each team must comprise three members
 - One Mediator, One Client, and One Counsel. The roles of the participants must remain consistent throughout all rounds of the Competition. Each Round shall comprise a Client-Counsel pair from each Side and 2 Mediators.
- Please note that there is no need for college authorization, and the cross-college team is allowed to participate.
- Participants are expected to choose their teams extremely carefully, and excuses with regard to team composition shall not be entertained unless unforeseen circumstances mandate otherwise.
