NMT 2.0 is scheduled for the third week of January (20–22 January, 2023), where teams representing leading Indian and International law schools will compete against each other in an exciting



league format. After two years of COVID-19 restrictions, we're excited to bring back the NALSAR tournament in person.

Our vision for the NMT is to make the tournament a great learning experience while ensuring that it remains accessible to a diverse range of ADR enthusiasts. The aim of the competition is not only to give a platform to budding lawyers to showcase their ADR skills but also to bolster the engagement of the legal community with ADR across the globe.

COMPETITION DETAILS



The tournament shall be in the form of a mediation competition. Each team shall consist of *3 participants* playing the roles of Client, Counsel and Mediator and the roles shall remain the same, throughout the duration of the tournament. A total of 24 teams will participate in the tournament.

The tournament shall have 3 Preliminary Rounds and 2 Advanced Rounds (the semi-finals and final)

TIME LIMITS ——

The time limit will be *60 minutes* for the preliminary rounds and *90 minutes* for the advanced rounds.

REGISTRATION FEE —

Indian Universities - *INR 12,000 per team*International Universities - *USD 150 per team*

ELIGIBILITY -

Participation is limited to students pursuing their Bachelor's Degree in Law (LLB or equivalent)
