



RULES & REGULATIONS

Terms mentioned below shall be defined as:

1. **"BATNA"** shall refer to the Best Alternative to a Negotiated Agreement and refers to the best thing a Party can do, without the consent of the other Party, if the Parties fail to reach an agreement.

2. **"CAUCUS"** shall refer to a separate meeting between the Mediator and a Team. During the Caucus, the overall time of the Mediation Session continues to run.

3. **"CONFIDENTIAL INFORMATION"** shall refer to the confidential elements to be considered in determining the strategy and tactics of the Negotiators' Teams in a given Mediation Session. The Confidential Information is for the exclusive use of each team and shall not be disclosed to the opposing team.

4. **"MEDIATION PROBLEMS"** shall refer to the official problems for the Competition released by the Organizing Committee.

5. **"MEDIATION PLAN"** shall refer to written case analysis as mentioned in Annexure 'A' of the rules and regulations.

6. **"MEDIATION SESSION"** shall refer to a session during which the Teams shall simulate a mediation procedure according to rules.

7. **"ORGANISING COMMITTEE"** shall refer to the Faculty Conveners & Student Conveners from Amicus Curiae, School of Law, JECRC University, Jaipur.

8. **"REQUESTING PARTY"** is the party that has to request the Mediation. Herein the composition and allotment for the same shall be decided by the organizing committee.

9. **"RESPONDING PARTY"** is the party to which the Competition has assigned the role of the party which has to respond to the requesting party.

ORGANIZATION OF THE COMPETITION

LANGUAGE: The Official Language of this Competition shall be English.

STAGES OF THE COMPETITIONS:

THIS COMPETITION SHALL COMPRISE OF TOTAL 5 ROUNDS:

- Preliminary -1
- Preliminary-2
- Quarter-final
- Semi-final
- Final

TEAM COMPOSITION:

- 1. Each Participating team shall comprise 3 members:
- One Neutral Mediator
- One Client
- One Negotiator

2. There shall be Separate Problems for different rounds with different Confidential Information in each round.

Provided, the mediation problems for both the preliminary rounds shall be the same but the confidential information shall be different.

3. One party shall be requesting party and the other shall be the responding party.

4. The mediator shall perform and shall be judged separately.

TEAM IDENTIFICATION AND ANONYMITY RULE:

After Registration, each Participating team shall be provided with a Team Code which shall serve as their Unique Identification Number (UIN). All Communications must be made in reference to this UIN.

DRESS CODE:

The Dress Code for this Competition is strictly formal. Any Violation of the Dress code shall lead to disqualification of the participating team from the Oral Rounds.

PARTICIPANT ROLES

MEDIATORS:

In each session, both the mediators must make an opening statement of not more than three minutes each. The mediators may decide the order and manner of coordinating opening statements. When a caucus is called, each mediator shall lead one caucus with either party during the mediation. The mediator not conducting the caucus shall observe and may ask clarifying questions at the end of the caucus. The performance of the Mediator shall be evaluated differently. Thus, the Mediator shall be neutral.

CLIENTS AND NEGOTIATORS:

The clients and negotiators shall each deliver their opening statements specifying their interests and goals for the mediation and negotiation session. Thereafter, the negotiators and clients are expected to work together and coordinate with the mediators to achieve their goals. All negotiators must act pragmatically and professionally throughout the sessions keeping in mind their respective roles.

MEDIATION PROBLEM

Release of Mediation Problem:

• There shall be a total of 5 Rounds in this Competition. There shall be different problems in each round.

• The Mediation problem for all the rounds shall be sent to the teams by the appropriate medium i.e., email.

Confidential Information:

• The Confidential Information for all rounds shall be released via mail (15-20 minutes before the rounds).

• The Teams are prohibited from disclosing the Confidential Information to their Mediator or another party during or before the competition.

• The Mediators shall have no access to the Confidential Information of any of the parties before or during the competition.

GENERAL PROCEDURES:

Timing: The Timing of the Rounds is designated in the following manner. Session Time stands for the Joint Session which includes Caucus & Break.

- The Participants are supposed to strictly adhere to the timings, mentioned above.
- The Caucus Session and Break are inclusive in the Joint Session, leading to continuity.
- During the competition, if the party requires more time than allotted, they may ask the judges for the same. It's up to the discretion of the judges.
- However, the Feedback Timing may increase as per the judges.



SESSION PROCEDURE

BREAK:

1. The Team can ask for a break during the Mediation Session of or not more than 2 minutes.

2. The Objective of the Break should be to have a team discussion where the Team shall be sent to the Break Out Room for the same. However, the time shall not exceed as given above in any circumstances.

CAUCUS:

1. During each Mediation Session, the Mediator, as well as the parties, are allowed to call for a caucus.

2. The Competing Team should call for caucus when they believe that they need input from the Mediators or there is some Confidential Information that they are not comfortable sharing. During the Joint Session. Reasonable use of caucus from the parties will be evaluated. A Caucus must not be used for any clarification related to the Preliminary Rounds.

3. Each team will be allotted 7.5 minutes for a caucus in each round. Thus, the whole caucus for both parties will last for not more than 15 minutes. There is no provision for Cross-caucus.

SCORING & EVALUATION

JUDGMENT CRITERIA:

1. Judging based on Mediation Plan as well as Oral Rounds.

2. The Judges would be duly briefed on the Judging Criteria before the Competition.

3. The Scoring of the Mediator and the Negotiators (Client-Counsel) will be done separately.

4. The Final Decision will always be in the hands of Respective Judges and the Organizing Committee.

FEEDBACK SESSION:

 The Feedback Session shall last for not more than the timing mentioned for each round. However, it may extend as per the Judge's discretion.
 The Feedback shall be provided to the teams before the Scoring.

GENERAL RULES OF SUBMISSION OF MEDIATION PLAN:

The Mediation Plan for the Preliminary Rounds must not be more than 2 pages in Times New Roman Font, 12-Font Size, and 1.5 spacing. Any deviation from this format will not be accepted. All the Mediation Plans will be scored individually and the highest-scoring team will be rewarded with the Best Mediation Plan at the end of the Competition.
