# ALTERNATIVE DISPUTE RESOLUTION CELL, GLC

The Alternative Dispute Resolution Cell (ADR Cell) was founded in 2016 with the objective of promoting alternative dispute resolution mechanisms and developing the set of skills required in Arbitration, Mediation and Negotiation within the student community. The Cell strives to foster an ADR culture amongst the students, believing that the emergence of ADR will reduce the burden on the Indian Judiciary.

The Cell does this by organizing multiple workshops and lectures conducted by experts; publishing a quarterly e-newsletter containing news, articles and quizzes for students wishing to pursue their career in this field; and hosting its flagship event: the ADR Weekend – an annual two day event which comprises a series of Seminars and Workshops by the top brass of the ADR field, aimed not only at informing but also instilling a perspective, attitude and aptitude for resolving disputes among the students.

# ABOUT THE COMPETITION

The GLC National ADR Triathlon is a distinctive ADR competition conducted by the Cell. With immense research and deliberation, the unique format of the “ADR Triathlon” was conceptualised.

Each team of 3 participating members represents only one party throughout the three rounds of the competition. The same problem progresses throughout the Competition, giving participants a slice of reality where developments progressively complicate a dispute.

- The first round shall be a Client Counselling Round, where a pair of counsels from each team will attempt to advise an in-house client.
- The second round shall be a Negotiation session.
- The third and last round shall consist of Mediation.
- All three rounds shall be cumulatively scored.

## WHAT MAKES THIS COMPETITION **UNIQUE**

A typical ADR Competition is designed only for one mode of dispute resolution, either Negotiation, Mediation or Client Counselling. The GLC NAT is a unique combination of all three in its ability to test a multitude of skill sets required for tactful dispute resolution. It comes close to the actual process of Dispute Resolution in the Status Quo, more so than any existing competition.

Students get an opportunity to dig deep into the problem, beginning from counselling the client, to negotiating the dispute with the other party across the table, and finally attempting to settle the dispute with the help of a mediator present to facilitate the process.

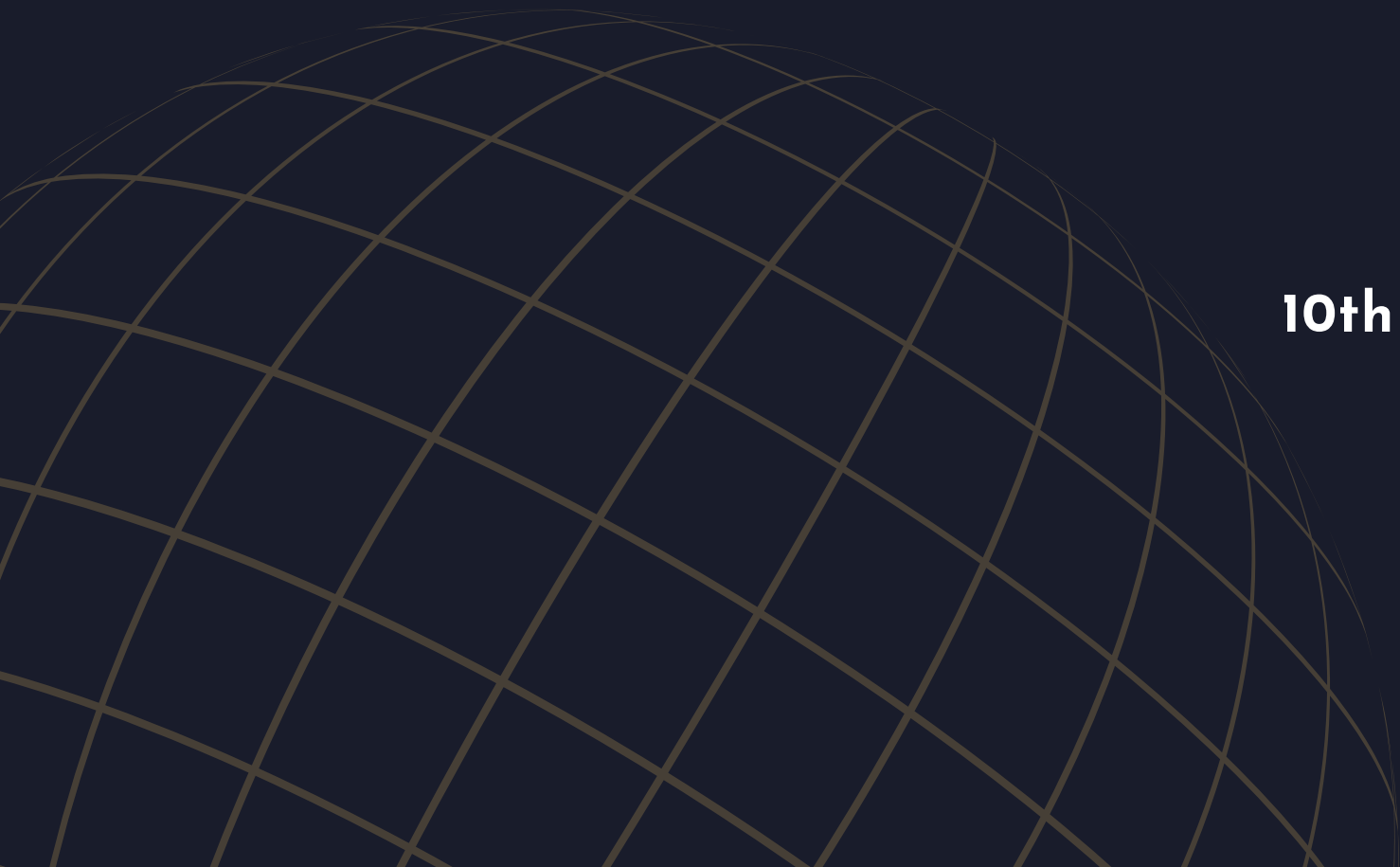

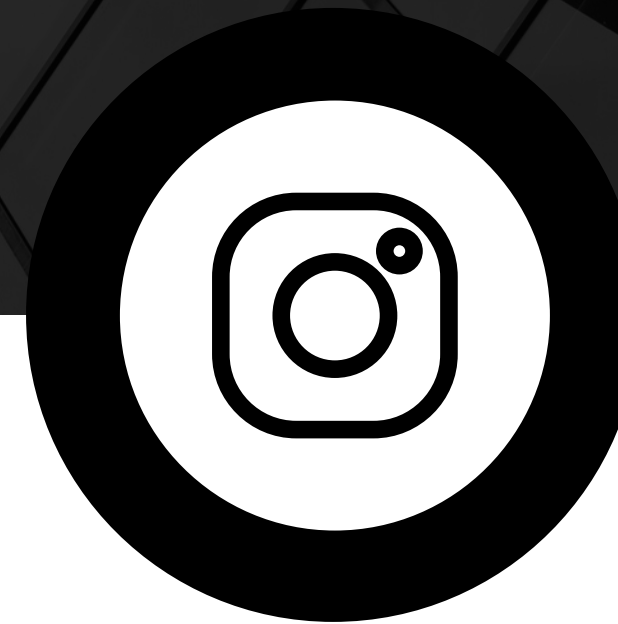
